2. Copy of applicant dog's current Registration Certificate from approved Mi-Ki club or registry. If registration is not from a Mi-Ki registry, then a current Wisdom Panel breed swab test must be done and results submitted along with current registration certificate.
3. Two current photos – One full front & one full side view of dog standing. (Must be able to see feet.)  
May submit third photo to be used on AMRA Certificate of Registration.
4. A copy of applicant dog's DNA profile from BioPet Vet Lab, VetGen or UKC.

**Please note: All photographs, DNA certificates, and pedigrees given/obtained by AMRA shall be the sole property of AMRA and can be reproduced or used in any way AMRA deems appropriate. No photographs will be returned.**

Optional items to submit with application:

1. A copy of your dog's CERF and OFA forms for patellas and heart signed by the appropriate authority rendering results. (Must be submitted if you want AMRA to list testing on breeders' page on the AMRA website.)
